



What: A 9th annual bodysurfing (Day 1) and handboarding (Day 2) competition with awards provided to top competitors in each division.

BODYSURFING: OPEN WOMEN, 19 & under, 20-34, 35-49, 50 & over

HANDBOARDING: OPEN WOMEN, 19 & under, OPEN MEN

When: A FRIDAY-SATURDAY (or SAT-SUN, surf permitting) event with holding period beginning Friday, June 23rd till Saturday, Sept. 9th. Check in begins at 7:00am. 1st competition heat starts promptly at 8:00am. Surf & wind conditions determine event call.

Entry Fee: EARLY - \$40 for one division or \$70 for two divisions.
LATE (BEACH) - \$50 for one division or \$90 for two divisions.
Includes one event t-shirt per participant.

Rules: Top 2 waves counted for each competitor in all preliminary competition heats. Wave count limit, if needed, to be determined on day of event. Priority format may be utilized depending on number of entries per division. Triangle/interference rule strictly enforced.

I also assign to the promoters of the said event, including the HCDA, the City & County of Honolulu, the State of Hawaii, and all associated sponsors, the exclusive commercial use of all photographs and photographic reproductions, television, and motion pictures taken of me during the event, whether in or out of the water. I also agree to conduct myself in a professional, sportsmanlike manner prior to, during, and after the bodysurfing competition and exhibition and while I am in the vicinity of the event. I have had an opportunity to be appraised of, and to review all the rules and regulations applicable to the competition and understand that any violation of these rules or any unsportsmanlike conduct will be cause for immediate disqualification from this contest by sole discretion of the contest director. I also agree to compete and appear in competition attire provided by the sponsors from time of issuance until completion of competition, exhibition, and during awards presentation. I also understand that if I damage or misplace my assigned colored cap before, during or after my heat, I will be obligated to pay DaFin \$60 to replace this custom-made cap. Failure to do so will disqualify my participation in future Point Panic Experience events. **ASSUMPTION OF RISK:** The undersigned further states that he/she merely assumes the risk for any injuries that he/she may sustain in connection with his/her participation in the event and he/she hereby releases and forever discharges the HCDA, City & County of Honolulu, State of Hawaii, all associated sponsors and their respective directors, shareholders, agents, employees, successors, assigns, and affiliated organizations from any injury or death arising out of or related to the event by signing this release form. **KNOWING & VOLUNTARY EXECUTION:** I have carefully read this agreement and fully understand its contents.
